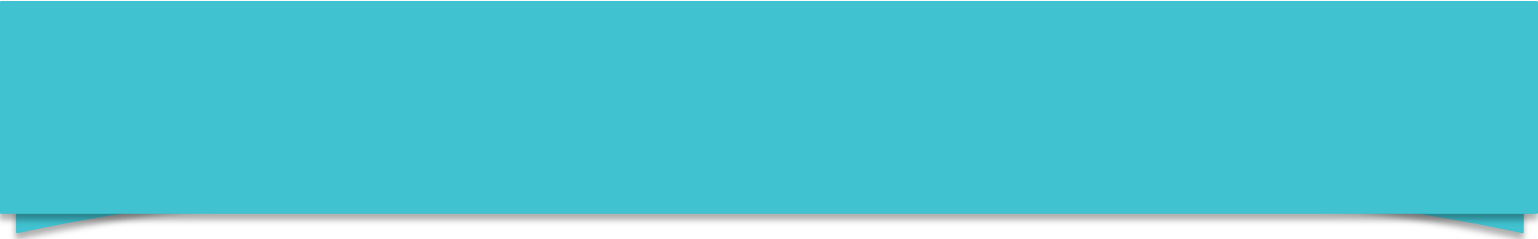

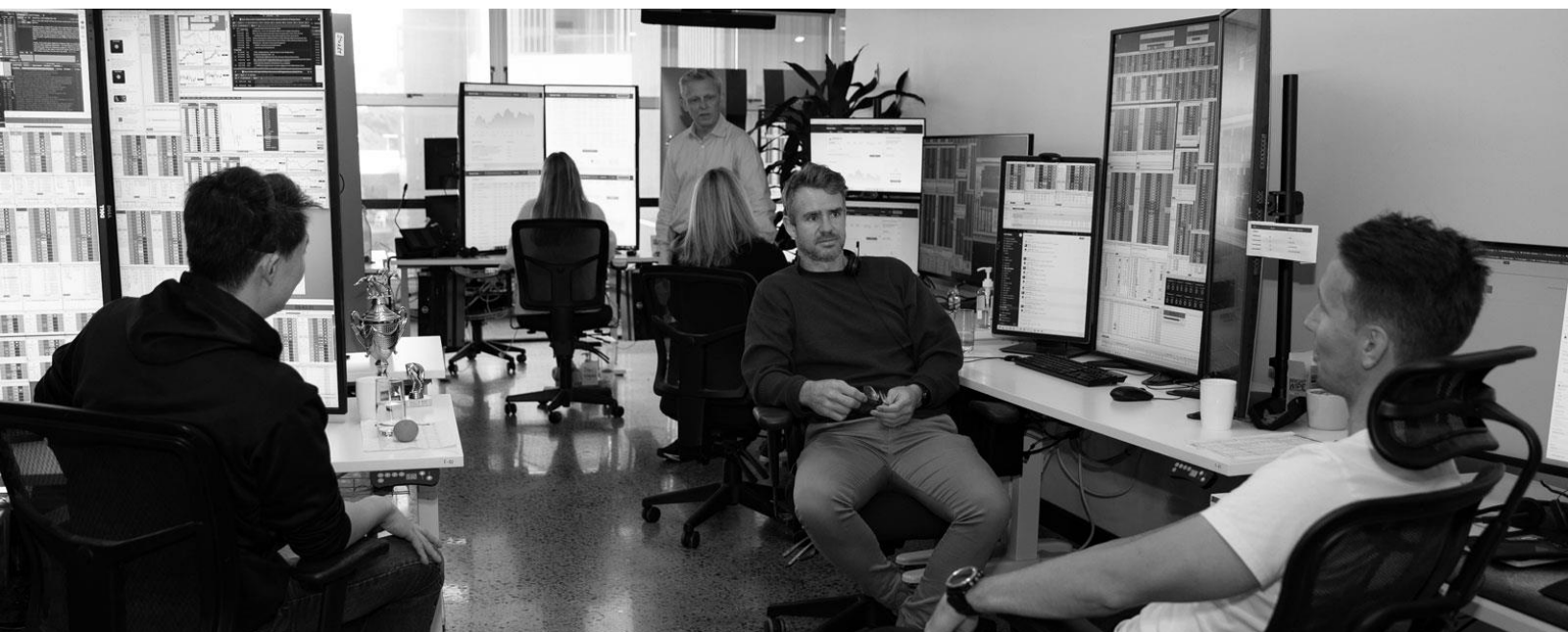

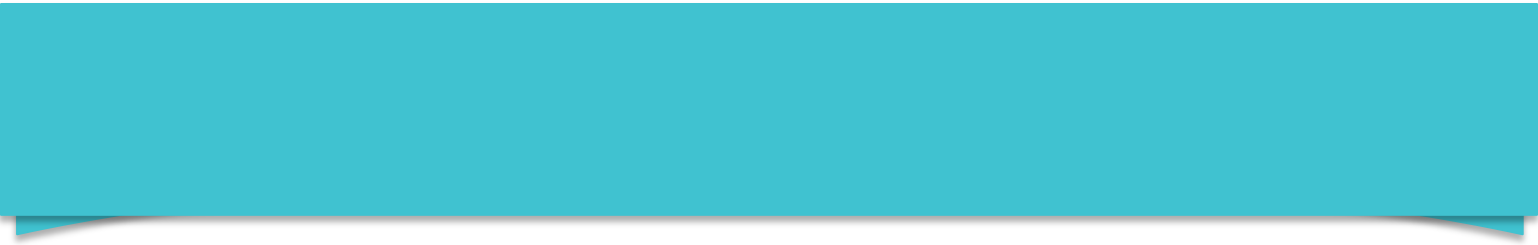


How Our Trading System Works

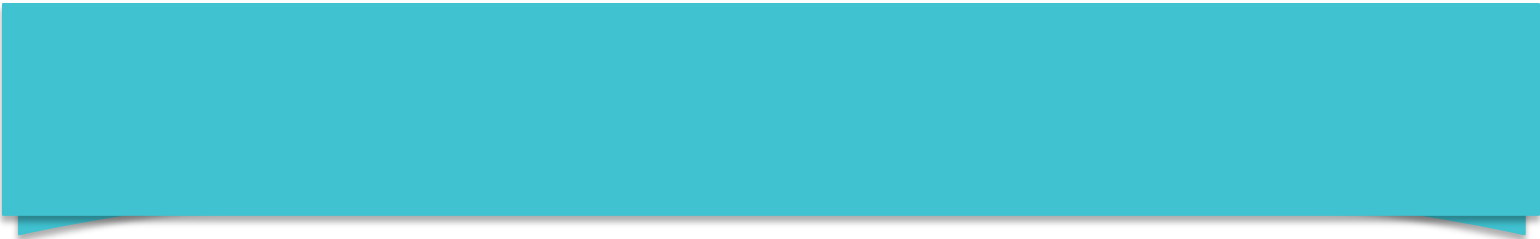

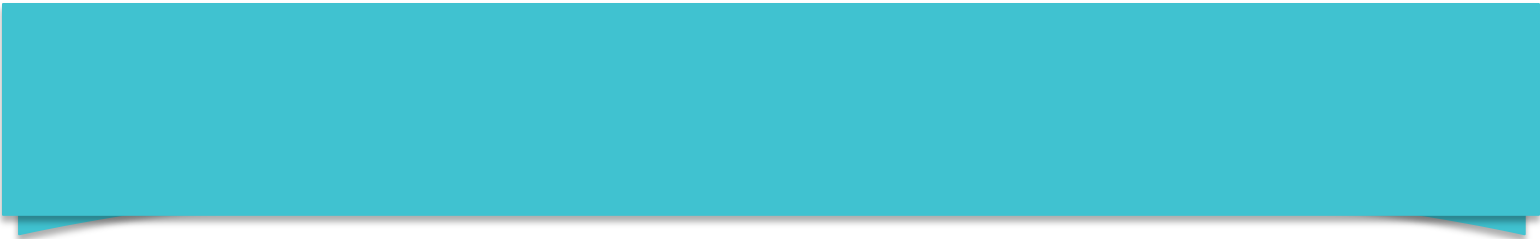

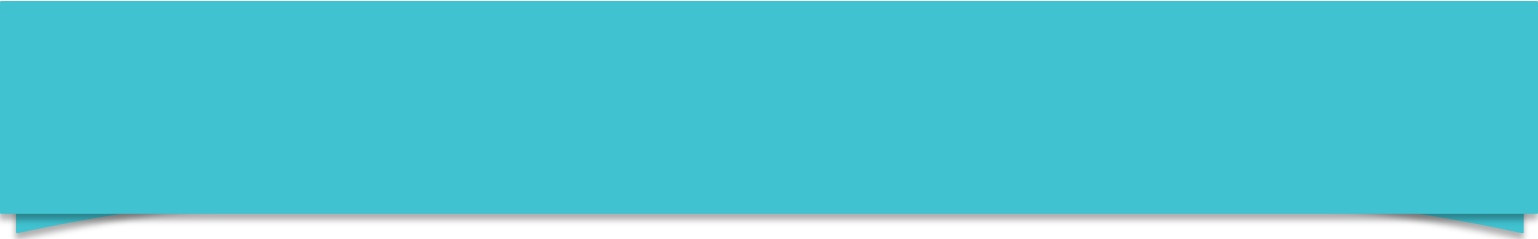
